The Telangana State Human Rights Commission was constituted vide G.O.Ms.No.170, GA (Spl.D) Dept., dated 28/11/2019, under sub-section (1) of Section 21 of the Protection of Human Rights Act, 1993 (as amended by Act No. 19 of 2019).

2. It is proposed to appoint Chairperson, Member (Judicial) and Member (Non-Judicial) in Telangana State Human Rights Commission.
3. Under sub-section 2 of Section 21 of the Protection of Human Rights Act, 1993 (as amended by Act No. 19 of 2019), following is the eligibility criteria.
 - i) Chairperson: One who has been a Chief Justice or a Judge of a High Court;
 - ii) Member (Judicial): One who is, or has been, a Judge of a High Court or District Judge in the State with a minimum of seven years experience as District Judge;
 - iii) Member (Non-Judicial): one from among persons having knowledge of or practical experience in matters relating to human rights
4. As per Section 24 of the Protection of Human Rights Act, 1993 (As amended by Act No 19 of 2019), the term of office of Chairperson and Members of the State Commission shall be 3 (three) years or until he/she attains the age of seventy years, whichever is earlier, and shall be eligible for reappointment.
5. The terms and conditions of service of Chairperson and Members of State Commission are in accordance with GO Ms.No.51, dated 30/01/2008.
6. Persons fulfilling the criteria and interested for appointment to the post of Chairperson, Member (Judicial) and Member (Non-Judicial) may submit their application in the proforma appended along with a resume, if any, by Registered Post, to the Office of the Chief Secretary to Government, Dr B.R.Ambedkar Telangana State Secretariat, Hyderabad-500022, by duly indicating on the cover "Application for TSHRC".
7. **All those who have applied in response to the earlier notification of even number, dated 14.07.2023, need not apply afresh again.**
8. Last date for receiving applications shall be 10/04/2024 before 5.00 PM.
