NOTIFICATION

**(CALLING FOR OBJECTIONS ON CERTAIN PROPOSALS FOR CHANGE IN NAMES/
ADDITION OF SYNONYMS IN RESPECT OF CERTAIN CASTES IN THE STATE LIST OF
BACKWARD CLASSES)**

1. The Telangana Commission for Backward Classes (Hereinafter called as 'Commission') has received representations from various caste representatives and organizations requesting for change of name and for addition of synonyms in respect of certain castes in the list of Socially and Educationally Backward Classes in Telangana State.

2. The Commission, in the discharge of its functions and in exercise of the powers conferred under Sections 9 and 10 of the Telangana Commission for Backward Classes Act, 1993 (Act No.20 of 1993), after making preliminary consultations and deliberations with the representatives of various castes, has decided to call for objections from the individuals, representatives and organizations, who are interested and who have objections in respect of the following proposals:
